### **5. Fire-fighting measures**

- **Suitable extinguishing media:**  
Carbon Dioxide (CO<sub>2</sub>), foam, powder, water
- **Special protective equipment for fire fighting:**  
Do not stay in danger zone without self-contained breathing apparatus.

Cool container with water spray from a safe distance. Contain escaping vapors with water. Prevent fire-fighting water from entering surface water or groundwater. Keep away from sources of ignition.

Highly Flammable. Vapors heavier than air. Forms explosive mixtures with air at ambient temperatures. Development of hazardous combustion gases or vapors possible in the event of fire.

Do not inhale vapors/aerosols. Ensure supply of fresh air in enclosed rooms.

Do not allow to enter sewage system.

- **Procedures for cleaning / absorption:**

Take up with liquid-absorbent material. Forward for disposal. Clean affected area.

- **Handling:**

Take precautionary measures against static discharges. Keep away from source of ignition. When using do not eat or drink.

Tightly closed, in a well-ventilated place. Keep away from source of ignition - no smoking.
